Hall of Fame Nomination Form

To be considered for induction into the Florida Suncoast Soccer League Hall of Fame, candidates shall be nominated as either administrators, coaches, players, or referees, and shall meet the criteria specified for that category. Individuals meeting the qualifications under two or more categories may be nominated for consideration under a single category, using primary/secondary categories, or specifying multiple categories. Length of service criteria may only be waived by the unanimous consent of the selection panel (Hall of Fame Committee and FSSL Board), under extraordinary circumstances.

Administrator candidates shall include persons who have served as officers/board members of the Florida Suncoast Soccer League and, in their capacities, have rendered exceptional service to the FSSL over a period of at least five years. This category also includes those distinct from these capacities that, by their assistance, sponsorship, or other valuable contribution, have furthered the development of adult amateur soccer in the Florida Suncoast Soccer League.

Coaching candidates shall be those who have served the FSSL community in a coaching capacity over a period of at least five years and have a demonstrated record of coaching success, exhibiting exceptional coaching and teaching ability. Candidates should also have contributed to the promotion and growth of a positive image for adult amateur soccer and its programs.

Player candidates shall be selected from those who have participated in a minimum playing period of ten years, exhibiting the principles of Fair Play and respect for other players. Nominees must have also demonstrated a respect for the game in general and for adult amateur soccer specifically during their days as a player.

Referee candidates shall have served the adult amateur soccer community in a refereeing capacity over a period of at least five years. Referees shall have achieved a

state and/or national grade and/or above. Other factors to be considered shall include, but not be limited to: participation in FSS League, State and National cups. This category shall also include referee administrative positions, such as instruction, assessment, assigning, and other referee activities within FSSL soccer.

All nominees shall be considered and chosen on the basis of having made a significant contribution toward the development and advancement of adult amateur soccer during their tenure with the Florida Suncoast Soccer League. Candidates may be either active or inactive in adult amateur soccer when nominated, and are eligible after their retirement. Deceased persons, if elected, shall be inducted posthumously.

*The Hall of Fame Committee along with the FSSL Board needs to be able to fairly and carefully consider all nominations. In order to do so, it is essential that all submitted material be clear, legible, and in similar format. The format and these instructions were developed to assure that the process is equitable and that all necessary information is available for review on a timely basis. Thank you for your understanding. **The Nomination Form must be received on or before May 1.***

- 1. **This Nomination Form may entirely completed electronically**, on the form itself, and emailed per the instructions, following these directions. Or, if preferred, the Committee will accept, in addition, an attachment that includes a candidate's bio and picture.
- 2. The Nomination Form itself may not be completed in any other manner (such as printing it out and typing or writing on it.).
- 3. Any additional supporting documents, materials, or additional information (if desired) may only be submitted by scanning those and attaching via a separate email, or else via postal mail. Such additional matter is not to take the place of anything required on the form itself.
- 4. **The nominee's clear quality photograph** must also be submitted and received by the April 15 deadline - whether by scanning and email or via postal mail,

- 5. The Nomination Form may be found on the FSSL web site or you may receive it as an email attachment.
- 6. You may **Open the Nomination Form in Adobe Reader** to complete it.
- 7. When you have completed the entire form, **print out a copy** for your own records.
- 8. Save a copy of the completed form.
